	<ul style="list-style-type: none"><li>• Maintained and developed the Gospel4Grampian website</li><li>• Maintained the G4G O365 tenancy which includes email accounts and secure file storage facilities and MS Teams which is used as the principle access method.</li><li>• Maintained and developed the G4G on demand Podcast service</li><li>• Added some event recordings which are broadcast.</li><li>• Maintained the G4G Podcast service to provide an “on demand” service for listeners.</li><li>• Worked with a local churches to broadcast and record live church services.</li><li>• Developed the use of live video broadcast to raise awareness of the G4G Project.</li><li>• Maintained equipment for and implemented Hardware and Software upgrades to the station computers.</li><li>• Utilized the Myriad Anywhere system to allow the Station Director and volunteers to manage station content and live broadcasts remotely.</li><li>• Myriad Anywhere was used to overcome the need to visit the station studio frequently.</li><li>• Maintained and operated the WebRadio Stats for reporting on station listeners.</li><li>• Continued to develop the 1 hour program called Gospel4You which was aired both online and on Short and Medium wave terrestrial radio across Europe, the Middle East and North Africa.</li><li>• Operated the station remotely during a period when Victoria Hall was undergoing maintenance work and physical access was not possible.</li></ul>

Donated facilities and services (if any)	During this financial period G4G made a financial contributions to the Victoria Hall in light of use of electrical power in the offices which have been the rental of office premises where the studio operates. Victoria Hall has provided use of these offices free of a rental charge for which the Trustees are very grateful. Money saved due to no rent being payable has been utilised to support the upgrade program for software and hardware.

### Other optional information

Office expenses and monthly software maintenance payments have been carefully managed and the Trustees continue to monitor the situation and are identifying new sources of funding. The stations operations costs have been met through regular financial giving and one-off fundraising activities by G4G members and officers. All financial transactions are detailed in the audited accounts.
